Our aim:

Our purpose is to improve the work prospects and wellbeing of people and their communities by:

Adult Learning aims to offer learning which:

- Improves your health and wellbeing
- Is built around what you want to learn
- Helps you to do more than you thought you could
- Supports you in taking the next step to further learning, volunteering or employment.

We offer a wide range of adult learning courses from short sessions to longer courses delivered from a variety of community venues across Blackburn with Darwen.

To make the most out of your learning, we ask you to:

- Tell us about what you want to learn
- Fill in an enrolment form
- Provide accurate information and proof of your identity to confirm your eligibility for a course and to allow us to request a Unique Learner Number (ULN) from the Learner Registration Service
- Let the tutor know about any extra help you may need during the course
- Keep letting the tutor know how it's going, what you want to do more of and what you need more practice with
- Attend every session and always be on time
- Contact your tutor or centre if you can't get to a session, or have to stop coming for any reason
- Tell us what you would like to do next.

Information, Advice and Guidance

- We hope you will enjoy your learning with the Adult Learning service. During each course, we will review your learning with you.
- We want everyone to consider the question "what next?" You might want to progress to another course in the same or a different subject. You might feel that you want to become a volunteer, get help to find work or find a better job.
- We offer a free, confidential one-to-one guidance service on learning, training and employment for all adults through our learning centres.

- T TELL: Tell us if you come across inappropriate
 websites in our classes. The Council filters inappropriate
 websites, but if they are displayed, tell your tutor. You can
